This is the last report that we received from Olga as of this printing: *"Many thanks for the information on people, which pray for Maxim. I always tell Maxim that you pray. Maxim says thank you to everyone for the prayer and the help."*

Yesterday I again was in hospital and Maxim very well looks. On Monday he has risen on legs for the first time and was able to go to the bathroom and he could take a shower for the first time since the illness. Last week I have brought the shaving machine tool and have cut Maxim's hair.

On Monday from Maxim took a puncture from a backbone. On Monday will take again, I think, that doctors have not found out in it a virus, therefore wish to take the repeated analysis."

Tuberculosis and Meningitis with nearly every organ of his body being affected. He was transported to yet another hospital and has no memory of that. Olga reported to us that he looked like a skeleton when she first saw him and that his skin was yellow. He could hardly move, could not open the left side of his mouth and his left eye was swollen shut. She also told us that he could barely speak.

Many weeks passed with Olga making regular visits to the hospital, taking food, pampers and disposable sheets. Because he could not hold a spoon, Olga would feed him and care for him.

We began getting the word out to some of our partners and the miracle began. It would seem that each time that one of our friends would write to let us know that they were praying for Maxim, soon after we would get a better report.

"You will chase your enemies, and they shall fall by the sword before you. Five of you shall chase a hundred, and a hundred of you

(We believe the doctors will find that Jesus has touched Maxim and healed him.)

"Maxim speaks that in hospital wishes to be two more months and when it will be warm, wants will return to our house."

PLEASE CONTINUE TO PRAY MAXIM! We are still waiting to hear the results of the tests. We want Maxim to be in complete health when he leaves the hospital. We have been told that he risks death if he leaves the hospital too soon. Most people have to stay in the hospital for at least a year, but of course we know Christ the Healer. Maxim wants to be at Restoration House for his birthday and so we are standing in agreement that God will enable this to happen.

There is so much more that God wants to do in Maxim. God has spared his life for a purpose. Please pray that as God reveals His plans to him, that Maxim will hear His voice and follow only His voice.


